TPO/22/0607 – The Parish Council noted the Tree Warden’s Comments and voted to return the following comment to the Tree Team:

The oak does need managing but it considers that reducing the side of the tree closest to the house by 3 meters is excessive and would be content with a smaller reduction of 2 metres. **Resolved Unanimous.**

TPO/22/0610 - The Parish Council noted the Tree Warden’s Comments and voted for the decision to be left to the Tree Officer. **Resolved Unanimous.**

TPO/22/0577 - The Parish Council noted the Tree Warden’s Comments and voted to return the following comment to the Tree Team:

*The Parish Council **objects** to the felling of this healthy tree. It considers it has high amenity value, both environmentally and aesthetically and has been in situ for many years prior to the houses. A crown reduction would be more acceptable.* **Resolved Unanimous.**

TPO/22/0573 - The Parish Council noted the Tree Warden’s Comments and voted to for the decision to be left to the Tree Officer. **Resolved Unanimous.**

Planning matters:

- Appeal at Arnewood Lodge, 223 Everton Road, Hordle SO41 0HE. Parish Council to resubmit its objection to the Planning Inspectorate.
- Cllr Horne raised the issue of the container at 20 Stopples Lane, Hordle, which has caused the demise of the tree at the front of the property. Office to raise with the Tree Team & Planning Officers.

6. To agree the bank reconciliation and statements for October 2022.

7. To agree the monthly payment schedule for November 2022.

This had been circulated in advance and forms part of background papers. **Resolved Unanimous.**

8. To consider grant applications from:

10. To note the Minutes for the Finance, Audit & Compliance Committee.

These had been circulated in advance and forms part of background papers. **Noted.**

11. To agree the budget and precept for 2023/24.

The proposed budget and associated Project List for 2023/24 has been circulated and forms part of Background Papers. The Council noted the recommendation of the Finance, Audit and Compliance committee to agree a precept of £180,000 to meet the budget requirements for 2023/24 and after discussion **resolved this amount unanimously.**

12. To consider Parish Council Health and Safety Issues.

- Councillors reported a flooding at the junction of Hordle Lane and Vicarage Lane. Office to report.
- Councillors requested an update to the ongoing gas works at Ashley Lane/ Pennys Corner. Office to investigate.

13. Clerk's report and correspondence.

This had been circulated in advance and forms part of background papers. Highlighted the HCC Consultation about proposed mineral extraction at Yeatton Farm, Hordle. She recommended as many councillors as possible to attend the drop in session at Forest Arts, New Milton on 13th December 4-7pm. In addition, the matter would be on the agenda of the meeting on 17th January.

A letter of support would be written to Hordle Community Association as part of their bid for grant funding from NFDC for works to the kitchen area of the pavilion.

The Clerk thanked all those who had helped and attended the Services of Remembrance throughout the parish. She reported that the Groundsman was to create a flower bed at the War Memorial gardens adjacent to the benches in the spring.

The Boules Court fence will be replaced like-for-like over the winter by the Groundsman.

14. To receive the Chair's report.

The Chair reported that she had attended the recent NFALC meeting and papers had been circulated to all councillors afterwards. She also thanks everyone for their support of the Remembrance Services.

15. To receive reports from District and County Councillors.

16. Matters for Information.

Councillor Morgan reported that she had given a presentation to New Milton Macular Society about the work of the Parish Council which had been well-received and the accessibility options on the Parish Council website were highlighted.
