# Item 16 - Clerks' Report August 2024

## **ExxonMobil CO2 Pipeline**

Route wil cut across land between Hordle and Everton. Consultation session on 30<sup>th</sup> August at The Bridge in Milford plus zoom session for councillors Thursday 22nd August 19:00 to 20:30 or Wednesday 4th September 19:00 to 20:30. Deadline for comments is 12th September.

### Water Supply at Golden Hill

Clerk investigating supply with Source4Business water. Will report back.

#### Insurance

Renewal due in October. Clerk is arranging new valuations for both pavilions.

### **Football**

Hordle Spurs have offered donated the four goals at Hordle Rec to the Parish Council with the following provisos:

- 1) The goals will not be locked up and therefore available for community use as per the current arrangement.
- 2) The goals will always be available and with priority use to NMTR whilst they are involved in the leasing of the ground for football use. There will not be any further charges applied in relation to the use of the goals given the negotiated lease of the ground for the 24/25 season.
- 3) The goals are not to be removed from Hordle Recreational ground unless deemed by HPC to be unsafe or condemned.
- 4) In the event a new Hordle Spurs FC negotiates with you in the future for the lease of the ground they will have priority use of the goals.
- 5) Any future maintenance/repairs/upkeep of the goals will become the responsibility of HPC.

## VASLR Farmers Walk, 11/07/24 - 13/08/24 (34 days)

We didn't note any issues during the time the VASLR was operational.

Incoming: 38,675 (Last month Everton Road, Hordle 27,698)

Outgoing: 37,305 (Last month Everton Road, Hordle 28,662)

% under speed limit is 80% which is low.





Highest speed, 72 mph outgoing, midnight Saturday. Cars pinged = 3 in half hour section. There is less than 1% at 40-45mph and also 45+mph. The 30-35 mph is the highest offending bracket with 15% of total cars.

As with previous two months, it is not clear if there are higher number of cars due to roadworks. However last year's data at site shows lower numbers of vehicles (33,000 approx) but higher fastest speed (90mph) with lower averages in and outward bound.
